The purpose of this letter is to notify you that The Narragansett Electric Company d/b/a National Grid (National Grid) recently established an information repository for the former 642 Allens Avenue Manufactured Gas Plant (MGP) Site (the Site) located at 642 Allens Avenue in Providence, RI. This notice is being provided to abutting property owners, tenants, easement holders, the municipality and members of the 642 Allens Avenue mailing list in accordance with requirements established in the Rhode Island Department of Environmental Management's (RIDEM) *Rules and Regulation for the Investigation and Remediation of Hazardous Materials* (Remediation Regulations) and the June 2017 Public Involvement Plan (PIP) for the Site. Should you be an owner of property that is leased, we request that you provide a copy of this letter to your tenants.

In accordance with the June 2017 PIP, National Grid has established an informational repository at the Knight Memorial Library in Providence, RI. Due to space limitations at the library, information has been and will continue to be provided in electronic format and will be consistent with the information available on the website maintained by RIDEM for the 642 Allens Avenue Site (<http://www.dem.ri.gov/programs/wastemanagement/site-remediation/Providence-Gas-Co.php>).

The Knight Memorial Library is located at 275 Elmwood Avenue in Providence, RI. The phone number of the library is 401-467-2625. Knight Memorial Library hours are Monday from 12:00 p.m. to 8:00 p.m., Tuesday through Thursday from 9:00 a.m. to 5:30 p.m. and Friday and Saturday from 12:30 p.m. to 5:30 p.m.
