Good afternoon Joe,

This email is to follow up with you on the voicemail I left you on July 31, 2019 regarding an emergency repair of a gas line at the 642 Allens Avenue property located in Providence, Rhode Island. All work was performed in accordance with the September 2012 *Soil Management Plan* (2012 *SMP*).

The approximate location of the emergency repair is shown on the aerial photograph of the Site.



The emergency repair was necessary to maintain day-to-day operations at the Site. The work included soil and groundwater activities that are not subject to the June 2017 *Public Involvement Plan* (*PIP*). As detailed in Section 1.1 of the *PIP*, the *PIP* does not apply to work necessary to maintain day-to-day operations at existing facilities or facility emergencies, including repairs and maintenance of the natural gas regulating facility, compressed natural gas fueling station, liquefied natural gas facility, and cement distribution facility, or for projects involving minor soil disturbances only (e.g. utility work, installation of fence posts, etc.).

The area disturbed during the emergency repair was restored with a RIDEM-approved engineered cap consistent with the 2012 *SMP*. In addition, GZA performed real-time work area perimeter air monitoring consistent with a Site-specific Health and Safety Plan and the 2012 *SMP*.

The emergency repair is not related to the liquefaction project and is in addition to the work detailed in the letter dated January 8, 2019.

This emergency repair will be documented in accordance with the 2012 *SMP* in an annual summary report that will be submitted to RIDEM.
