

Approved Online Courses and Webinars Continuing Education Unit (CEU) Opportunities for OWTS Professionals

CEU REQUIREMENTS

12 CEUs are required in a three-year license cycle (4 CEUs per year since a license was issued, or last renewed). Online courses and webinars have the same value as live in person courses.

RETAKING COURSES/WEBINARS

Courses may be retaken and the CEUs applied to license renewal if there is at least one-year between the dates.

DOCUMENTATION OF PARTICIPATION/COMPLETION

The certificate of participation or successful completion must be submitted with the OWTS designer license renewal application form.

CEU APPROVAL REQUESTS

Additional online courses will be reviewed for CEU value as requested. Requests for approval of additional courses for OWTS Licensing CEUs may be submitted to the department using the request form provided on the DEM OWTS website: <http://www.dem.ri.gov/programs/water/owts/licensing/ctgeduc.php>

Online courses and webinars will be reviewed for CEU value according to the applicability of the content to the activities performed under RIDEM-issued OWTS licenses and assigned at a rate of approximately 1/2 CEU per hour of the course or webinar.
