Parking Lot G Conditions:**

- One parking placard shall be issued for up to two vehicles registered to the same principal address, listed on each vehicle registration.
- Each parking placard is valid for either of the two vehicles listed on the placard, no loaning of the parking placard is allowed.
- Only one vehicle listed on the parking placard may park in lot G at a time.
- No parking along the North side (adjacent to entrance) November 1st – March 31st
- Vehicles without a valid placard for the current or upcoming calendar year are subject to towing.
- **All parking placards must be displayed year-round in a manner that is easily visible while in the lot.**
- **No campers, trailers, or vehicles over 8,800 lbs. GVRW are allowed. POSITIVELY NO EXCEPTIONS.**

The issuance of this placard to a vehicle authorizes the parking of the subject vehicle on a SPACE AVAILABLE BASIS. While staff will make every reasonable effort to ensure that adequate parking spaces are available for all vehicles with annual parking placards, it is possible that there will not be enough parking available at times of peak demand including, but not limited to holiday periods. Any misuse of parking placards will result in the immediate confiscation of placard by the Division of Coastal Resources.

RATES

Rhode Island resident- \$150.00

- Proof of residency required: Valid RI Driver's license or proof of being an RI registered voter.
- Valid/current RI vehicle registration.

Rhode Island Senior Citizen Discount- \$75.00

- Senior Citizen Discount applies to those age 65 or older.
- Driver's license required. Proof of RI Residency (same as above).

Out of State Resident- \$250.00

- (No out of state senior citizen discount)
- **All non-Rhode Island vehicles will be subject to out of state rates.**

PAYMENT

Cash, Credit Card*, Money Order or Check (payable to the State of Rhode Island), with proper ID will be accepted.
