Pursuant to the Rhode Island Department of Environmental Management (RIDEM) <u>Rules and Regulations</u> for the Investigation and Remediation of Hazardous Material Releases (the Remediation Regulations), this letter has been prepared to provide notification of the on-going Site Investigation at the above-referenced property.

The purpose of the Site Investigation is to evaluate the nature and extent of the potential subsurface contamination at the Site. The work to be performed on the above-referenced property includes the advancement of test-pits, soil borings and monitoring wells, and the collection of environmental samples. Site Investigation field activities are scheduled for May 21, 2014 and will continue into June 2014. Resource Controls will be conducting these field activities on behalf of the Responsible Party.
