

## Historical photos of the former Gorham facility


- •Constructed late 1890's; Closed 1985

### **Completed Remediation Activities**

#### Groundwater Remediation Activities

- In-situ injections (2002, 2004)
- Groundwater Extraction & Treatment (2013 present)

### Upland Remediation Activities

- Parcel A 2001 (Cap soil, asphalt and building) Retail
- Parcel B 2006 (Cap soil, asphalt and building) High school
- Phase I, Parcel C-1 (Slag Removal 2006, Cap 2012) Undeveloped

# Completed Remediation Activities – Groundwater Injection Events



- Parcel A
- •Two Injection Events 2002, 2004
- Source Area was targeted and treated with an oxidant
- •Chlorinated solvents Tetrachloroethylene (PCE) and Trichloroethylene (TCE)
- •Reduced impacts by over 50%


# Completed Remediation Activities – Groundwater Extraction and Treatment System



- Parcel A
- System installed in 2013
- Control groundwater flow
- •3 Extraction Wells and On-Site Treatment Compound
- •To date, almost 6,000,000 gallons treated and 120lbs of contaminants removed
- Routine Compliance sampling and groundwater monitoring
- Long-term operation is anticipated


# Completed Remediation Activities – Parcel A Soil Remediation






- Work completed in 2001 to allow for retail development
- •18,600 tons of petroleum impacted soil treated
- Treated material reused on site
- Capping accomplished with asphalt, soil and buildings
- Industrial/Commercial criteria
- Ongoing monitoring of cap integrity
- Sub-slab mitigation systems

# Completed Remediation Activities – Parcel B Soil Remediation (City of Providence)



- Parcel B
- Work completed by City of Providence in 2007
- Soil, asphalt and building caps
- •Residential/unrestricted criteria
- Sub-slab vapor extraction system
- Ongoing monitoring

# Completed Remediation Activities – Parcel C-1 - Phase I - Soil Remediation



- Parcel C-1 (Park Parcel)
- Former slag pile addressed in 2006
- Work completed in 2012
- Soil cap location specific
- Fill areas addressed
- Residential criteria
- Ongoing monitoring



# Summary of Parcel C and Phase III Soil Investigations


- Historical Use of Parcel C and Phase III Areas


### **Tentative Schedule of Remediation Activities**

- February 20, 2015 Public Comments due to RIDEM
- March 2015 Draft Remedial Action Work Plan to RIDEM
- March 2015 Submit federal permit application
- May 2015 Final Remedial Action Work Plan/Permit Approvals
- June 2015 Construction contractor selected
- July 2015 Start construction
- November 2015 Complete construction
- January 2016 Construction Completion Reports
