Here's the figure. The proposed new wells are MW-5, MW-6 and MW-7, in green. These locations would be easier to maintain over the long term. No evidence of groundwater contamination has been detected since the first wells were installed during the SIR, so there is no evidence that a source exists that will impact groundwater in the future.
