Dear Richard:

The plaintiffs have no objection to DEM's request for an extra two weeks to complete the Draft Five Year Review report. Although you are new to the case, the plaintiffs have always taken the position that strict adherence to deadlines was less important than insuring a quality product at the end of the process.

With that in mind, I expect to be requesting an extension of the comment period to respond to the Five Year review. For almost a year now, the plaintiffs have been trying to obtain technical assistance from EPA regarding the Five Year review. Last summer we asked DEM to extend the comment period for recommendations on issues the Five Year review should focus on. DEM denied that request because EPA did not know when the T/A provider could be contracted to provide the assistance. Plaintiffs have continued to press EPA for a T/A provider and as of today EPA still has not determined when the T/A provider will be in place. Hopefully between now and November 15th EPA will determine when the T/A provider can start work. I hope that DEM will accommodate a request to extend the comment period on the 5 year draft to enable the T/A provider to review the report and the many documents in the record to date.
