All minors, defined as those under twenty-one (21) years of age in this context, must be accompanied by a "qualified adult" when using the range. A "qualified adult" is any person twenty-one (21) years of age or older who is permitted by law to possess and use a firearm. The "qualified adult" must also possess a valid range permit and is directly responsible for the actions of minors under their supervision. The "qualified adult" must assure—by direct supervision—that minors follow all safety policies. The "qualified adult" shall supervise only one (1) minor at a time.

**Parental/Guardian Release:** In order to afford the minor permit applicant identified on this Target Range Permit Application the opportunity to participate in the target range facility operated by the State of Rhode Island, Department of Environmental Management, Division of Fish & Wildlife, located at the Great Swamp, *I hereby certify the following under the penalties of perjury:*

1. I am the parent and/or legal guardian of the Minor permit applicant identified on this application (hereinafter the "Minor").
2. I shall assure the State of Rhode Island that that the Minor is adequately supervised at all times while the Minor is at or near the target range facility.
3. I, at all times while the Minor is at or near the target range facility, shall hold harmless the State of Rhode Island including any departments, offices, agents, or employees of the State and further shall assume full liability for any injuries which may be suffered by the Minor or caused to others by the Minor. Specifically, I shall hold the State and its agents harmless from all claims or damage suits arising from any actions at or near the target range facility, either by way of my omission or commission, which may be suffered by the Minor or caused to others by the Minor.
