### **Multipurpose Vessel License**

There will be a total of 15 new RI Multipurpose Vessel Licenses issued in 2024. The multipurpose vessel license shall allow the vessel owner to designate any operator to engage in commercial fishing for all marine species aboard their owned vessel, provided the vessel owner has consigned a multipurpose fishing license to the department. The department may then re-issue the consigned multipurpose fishing license to the commercially declared fishing vessel as a multipurpose vessel license. To obtain a Multipurpose Vessel License, the following information is required:

- Signed & completed application, fee One Thousand Dollars (\$1,000.00) check or money order payable to RI DEM, or credit card, convenience fees apply to credit card payments — Note: License fee of \$1000.00 charged only if successful applicant, please do not submit payment with this application
- Copy of 2024 RI Multipurpose Commercial Fishing License
- Copy of USCG Documentation/ State Registration for the vessel receiving the license
- Completed Taxpayer Certification
- Documentation of RI based commercial fishing landings to meet activity standards
- For individual vessel owners, please submit Social Security Number- see attached <u>Taxation</u> Certification
- Partnerships, Corporations or LLC Corporations which own the vessel, please submit FEIN- See attached <u>Taxation Certificate</u>
  - For Partnership or Corporation Vessel owners, please submit either "Partnership Agreement" or "Corporation Papers" & Disclosure Form- Yearly Requirement.
  - LLC Corporation vessel owners complete Certificate of Disclosure or Corporation of LLC & submit Certificate of Organization
- Partnerships, Corporations or LLC Corporations which own the vessel, please submit attached Certificate of Authority

# Guidance for Applicants Seeking New Multipurpose Vessel License 2024

As described in the accompanying document entitled *New Standard Fishing License/Endorsement Opportunities Available for 2024*, fifteen (15) new Multipurpose Vessel Licenses will be issued in 2024. As further described in the accompanying document, there are eligibility requirements for this license beyond those for traditional commercial fishing licenses. This document provides guidance for applicants seeking the new Multipurpose Vessel License, including how to determine if you are eligible and properly submit an application by February 29, 2024.

Any questions regarding the application process should be directed to DEM's Office of Boat Registration & Licensing at 401-222-6647. All applications & supporting documentation must be mailed, or hand delivered by February 29, 2024 to the DEM, Office of Boat Registration & Licensing 235 Promenade St., Room 360 Providence, RI 02908-5767.

#### I. Eligibility Requirements

Q1: Do you hold a valid Multipurpose Fishing License?

If no, you are not eligible for a Multipurpose Vessel License. If yes, proceed to next question.

Q2: Are you a natural person listed as the sole owner of a commercially declared fishing vessel in Rhode Island?

If no, go to next question.

If yes, proceed to Q5.

Q3: Are you named as President, Vice President, Treasurer, Secretary, Director, or Stockholder of the corporation which owns a commercially declared fishing vessel?

If no, you are not eligible for a Multipurpose Vessel License.

If yes, proceed to next question.

Q4: Has the corporation that owns the commercially declared fishing vessel been registered in good standing with the State of Rhode Island for at least the preceding five (5) years?

If no, you are not eligible for a Multipurpose Vessel License.

If yes, proceed to next question.

Q5: Have you been a Rhode Island resident for at least the last five (5) preceding years?

If no, you are not eligible for a Multipurpose Vessel License.

If yes, proceed to next question.

Q6: Has your Multipurpose Fishing License been actively fished in each of the preceding five (5) calendar years?

If no, you are not eligible for a Multipurpose Vessel License.

If yes, proceed to next question.

Q6: Has your Multipurpose Fishing License been actively fished in each of the preceding two (2) calendar years on the same vessel that will be named on the Multipurpose Vessel License?

If no, you are not eligible for a Multipurpose Vessel License.

If yes, you are eligible for consideration for the new Multipurpose Vessel License, in accordance with the selection process delineated in the accompanying document.

### Additional Information Regarding Application for License:

- To be considered, you must submit an application by February 29, 2024, indicating that you wish to obtain a new Multipurpose Vessel License.
- Your application must include a brief cover letter, indicating that you are eligible as an active holder Multipurpose Fishing License as described above.
- Along with your application, you must submit the dated transaction records necessary to verify your fishing activity.
- You must submit a valid (unexpired) US Coast Guard Documentation or a valid (unexpired) State vessel Registration that indicates the owner of the vessel.
- If the vessel is owned by a corporation you must submit a signed and notarized Certificate of Authority form and Certificate of Disclosure of Corporation included in the accompanying document.
- Applicants will be entered into a lottery for determination of license issuance.
- All transaction records will be subject to verification by the Department in accordance with dealer reports submitted to the Department via the SAFIS reporting system or dockside sales logbooks submitted to the Department. DEM will disqualify from consideration due to lack of eligibility any application that is not accompanied by a sufficient number of valid transaction records.

#### **Additional Information regarding Licensing:**

- You must renew your Multipurpose Fishing License for 2024 to be eligible for consideration for this new license type.
  - As a result, selected license holders will be charged \$550 for the Multipurpose Vessel License in the first year of issuance only. This represents the cost difference between the Multipurpose Fishing License (\$450) and the Multipurpose Vessel License (\$1000).
  - After the first year of issuance, the annual fee for the Multipurpose Vessel License will be \$1000.
- All commercial licenses renewal applications must be received by the RIDEM Office of Boating and Registration by February 29, 2024.
- If you are selected for issuance of a Multipurpose Vessel License your Multipurpose Fishing License will be consigned to RIDEM and be temporarily invalid.
- You cannot be issued any other commercial fishing licenses while your Multipurpose Fishing License is consigned.
- If selected, you must install a RIDEM approved vessel monitoring system on aboard your vessel which will be active at all times.
- Multipurpose Vessel Licenses will be issued annually until 2026, at that time they will be reverted back to a Multipurpose Fishing License and issued to the original holder.
- Term of Multipurpose Vessel License: No Multipurpose Vessel Licenses will be issued after December 31, 2026. During the 2027 license renewal period, any person who was issued a Multipurpose Vessel License holder in 2026 must surrender their Multipurpose Vessel License to be re-issued their consigned Multipurpose Fishing License.
