The Rhode Island Department of Environmental Management Office of Waste Management (the Department; RIDEM OWM) has reviewed the following documents regarding the site investigation at the above-referenced site:

- Letter report dated December 18, 2000, submitted by Beveridge and Diamond;
- Letter report dated September 26, 2000, submitted by Beveridge and Diamond;
- Letter report dated June 20, 2000, submitted by Beveridge and Diamond; and
- Report dated January 13, 2000 and submitted by Vanasse Hangen Brustlin, Inc..

The Department regards these reports as together constituting the Site Investigation Report (SIR) pursuant to Rule 7.03 of the <u>Rules and Regulations for the Investigation and Remediation of Hazardous Material Releases (Remediation Regulations)</u>. The Department acknowledges that the site investigation activities are complete. However, the Department is not yet able to formally approve the SIR due to the necessity to first receive public comment on the completed package with the preferred remedial alternative.

Rules 7.07 and 7.09 of the <u>Remediation Regulations</u> address the requirements for public notice regarding the substantive findings of the completed investigation and the opportunity for public review and comment on the technical feasibility of the proposed remedial alternative.

The Department will formally approve the SIR, in the form of a Remedial Decision Letter, upon Department approval of all final responses to relevant public comments. At that point the detailed Remedial Action Workplan will undergo final Department review.

As the Performing Party, you are responsible for properly conducting the public notice. A template is enclosed for your use.

In accordance with the Rhode Island Department of Environmental Management's (RIDEM's) Rules and Regulations for the Investigation and Remediation of Hazardous Material Releases (the Remediation Regulations), and the Industrial Property Remediation and Reuse Act (Rhode Island General Law 23-19.14, Section 11) if applicable, Performing Party's name is providing notice to abutters that a Site Investigation for the above mentioned property has been completed. Requests must be received by the Department before 4:30pm on the final day of the comment period, and may be made in writing to the address below or by calling the telephone number listed below. RIDEM will consider all substantive written comments prior to issuing its final approval of the proposed remedial alternative.
