Hi Ashley,

Attached is the final version of the notice (in English and Spanish) as well as the finalized mailing list. A hard copy has been sent to you at RIDEM. I added a column in the mailing list to denote whether the notice was provided via hard copy or email. Hard copies have been printed and placed in the mail, and the emails have been sent. I requested a Read Receipt for the emails to the petitioners so we'll know if they've opened the email. Note that some of the petitioners/residents are being sent a hard copy – this is because upon sending the email with the notice, their emails bounced back and the emails were therefore not sent. Thankfully these recipients also provided an address, thus they will be sent hard copies of the public notice letters.

As for the stenographer, yes we plan to use one of the three that Jenna sent previously (Rebecca Forte, Mary Ellen Hall, or Esquire Deposition Solutions) that were deemed to be qualified, especially given that the meeting room is capped at 50 so some will be relying on the transcript of the meeting. I'll be reaching out to all three early next week to inquire about their availability, just wanted to nail down a venue/date/time before trying to schedule one.

I went to the Knight Memorial Library yesterday. I was unable to speak to the library manager, but the space itself looks good. They have various chairs and tables, as well as a small elevated stage area, so we'll likely plan to get there early so that we can set up the space. As for audio/visual accommodations, the library shares that equipment with the other community libraries of Providence. I have an inquiry out to the library contact from which I received approval for our meeting request; we can make do with a speaker system if need be. If we aren't able to use a projector for PowerPoint purposes, we'll put together handouts to help guide the meeting.
