The filing of this application shall not stay or modify any time limitation or condition of the permit.		

NOTES: RIDEM may inspect any permitted construction site. Owners and operators can avoid penalties by complying with all permit conditions, including, but not limited to: maintaining all required signed Soil Erosion and Sediment Control Plans onsite; conducting required inspections and maintaining inspection records onsite; properly installing, monitoring and maintaining erosion and sediment controls; avoiding environmental impacts; and keeping all construction and disturbance activity within the approved limits of disturbance.
