Department of Environmental Management Division of Coastal Resources Parking Lot G Conditions

- One parking placard shall be issued for up to two vehicles per principal residence which is listed on the completed and approved applications
- Each parking placard is valid for either of the two vehicles listed on the placard, no loaning of the parking placard is allowed
- Only one vehicle listed on the parking placard may park in lot G per day
- No parking along the North side (adjacent to entrance) November 1st March 31st
- All parking placards must be displayed in a manner that can be easily ready while in parking lot G
- No campers, trailers, or vehicles over 8,800 lbs. GVRW are allowed. POSITIVELY NO EXCEPTIONS

The issuance of this placard to a vehicle authorizes the parking of the subject vehicle on a SPACE AVAILABLE BASIS. While staff will make every reasonable effort to ensure that adequate parking spaces are available for all vehicles with annual parking placards, it is possible that there will not be enough parking available at times of peak demand including, but not limited to holiday periods. Any misuse of parking placards will result in the immediate confiscation of placard by the Division of Coastal Resources.
