## Rhode Island Department of Environmental Management FY2002 and FY2003 Work Plan Office of Criminal Investigation

- I. **Program Name and Description**: The Office of Criminal Investigation coordinates criminal enforcement proceedings for the Department primarily pertaining to hazardous waste, solid waste, medical waste, water pollution, air pollution, submission of false documents to DEM regulatory programs, and internal affairs.
- II. **Mission of Program, Office or Division**: Office of Criminal Investigation. Through timely and appropriate complaint investigation the OCI will protect public health, safety, and welfare by preventing environmental degradation and restoring regulated natural resources subjected to unauthorized alterations, releases of pollutants, dumping, or other activities that harm a natural resource by investigating and prosecuting violations that appear to be intentional, willful, or knowing.
- III. Program Highlights: (status, major successes, major problems, major initiatives): The OCI has initiated over 1,134 investigations of which approximately 300 cases have been prepared for prosecution since 1983 resulting in about 2500 felony charges being brought against individuals and corporations. These cases have resulted in approximately \$9,500,000 in fines and penalties. Portions of the funds generated by this program are held in an account that enables the Department to respond to environmental emergencies.

The OCI will continue to support the regulatory divisions within the Bureau of Environmental Protection against criminal violations of environmental laws that are the most severe deviations from the requirements and typically result in serious risk to human health and the environment. The OCI will continue to aggressively investigate deliberate acts of non-compliance, repeated instances of gross non-compliance, deliberate concealment or falsification of information, and gross non-compliance with permit or license requirements. The primary regulatory divisions that the OCI will continue to support are the Office of Compliance and Inspection, the Office of Waste Management, Office of Air Resources, and the Office of Water Resources. The OCI will consistently and aggressively pursue prosecution through timely response to complaints referred by these regulatory offices and continue enhancement of internal communications through Enforcement Coordination Committee meetings, and the Global Enforcement Response Policy.

The office consists of five investigators and one clerical. One investigator position is currently vacant. This position is expected to be filled in FY2002. With the small number of investigator positions and limited budget, the OCI realizes the necessity for instituting a research and development program to utilize new methods of investigating complaints and obtaining evidence. The current condition of the surveillance and evidence recording equipment is outdated. The office will attempt to utilize money received from fines to purchase new technology and surveillance equipment to enhance its investigative abilities.

The OCI will continue in keeping hazardous waste violation investigations the top priority, however; the OCI will additionally explore ways to expand criminal investigations into water pollution violations in watershed areas. In order to accomplish this, the OCI will improve communications with the various wastewater treatment facilities including the Narragansett Bay Commission in order to identify and coordinate joint investigations in an attempt to reduce pollution at the source. The OCI will further explore ways to expand criminal investigations of air pollution violations. The OCI will research new methods of obtaining evidence (air samples) and attempt to apply them in the prosecution of those who knowingly release toxic air pollutants that pose an unreasonable risk to public health.

Over the last year there has been an increase in complaints in reference to the illegal disposal of shredded construction and demolition debris and the obnoxious odors emanating from the illegal disposal sites. The OCI with the support of the Attorney General's office will continue to vigorously investigate and prosecute the illegal operation of solid waste/construction and demolition debris facilities and the illegal disposal of shredded construction and demolition debris in an effort to minimize and eliminate the impacts and risk to human health and the environment.

The OCI is expected to have computer access with the regulatory CITRACK system (which will become part of the Permit Streamlining) as part of the Information Management Unit's initiative that will allow the OCI to access regulatory reports and inspections. This will improve computer information retrieving, data tracking, and preparing reports for criminal investigation purposes. The OCI's computer link with the Office of the Attorney General's Bureau of Criminal Identification (BCI) was recently interrupted with the advent of the BCI's new computer system. This is the system that allows law enforcement agencies to conduct criminal background checks on individuals. The OCI with the assistance of the Office of the Attorney General, the DEM's Information Management Unit, and the State Police RILETS will seek to regain access to the BCI system.

The OCI will continue its partnerships in environmental law enforcement endeavors with the Federal Bureau of Investigation, the Environmental Protection Agency, Criminal Investigations Division; and the state and local police.

The OCI provides an Environmental Crimes Training Project to new recruits attending the RI Municipal Police Training Academy and the RI State Police Training Academy. The OCI will revise and update the training program to include new initiatives utilizing the Power Point program. The OCI will continue to coordinate in-service training programs for regulatory inspectors in conjunction with the Northeast Environmental Enforcement Program. The OCI will seek to expand the training of environmental crimes and pollution prevention education with local and state agencies, as well as, with public and private organizations.
