#### SUSTAINABLE WATERSHEDS OFFICE

**I. Program Name and Description**: The Sustainable Watersheds Office is a new office that coordinates DEM's involvement in the Rhode Island Watershed Approach. The goal of the watershed approach is to preserve, protect, and restore Rhode Island's environment through collaboration and consensus building. This is done by establishing broad-based partnerships, called watershed teams, to include all the key stakeholders within a watershed. The intent of the partnership is to bring additional resources, expertise, and different perspectives to the table to comprehensively identify, prioritize and solve complex environmental issues. We also coordinate what have traditionally been separate government programs in order to use existing resources more effectively.

The watershed approach is a top DEM priority and we have developed action plans for two watershed areas: Woonasquatucket and South County. In addition, two full-time watershed coordinators have been assigned to work with and assist watershed stakeholders to make sure that we efficiently respond to their needs and concerns. While most state watershed approaches limit their focus to water quality, the Sustainable Watershed Office effort is much broader and provides coordination and technical assistance to address the following issues:

- Planning for growth
- Creative land use techniques
- Alternative natural resource-based businesses
- Habitat restoration
- Open space preservation
- II. Program Highlights: Highlights and initiatives implemented in this work plan include:
  - Develop an Urban Environmental Design Manual.
  - Complete Greenspace or Community Character Preservation Plans in the South County and Woonasquatucket watershed.
  - Prepare a Conservation Development Guidance Manual for local officials and developers.
  - Assist the Governor's Growth Planning Council to establish growth center criteria to target state investments and to eliminate infrastructure obstacles for compact growth.
  - Prepare a watershed action plan for the Blackstone Watershed.
  - Coordinate action plan implementation efforts in the South County and Woonasquatucket watersheds.
