What Does This Ordinance Cover?

• Stormwater

- Illicit Discharge and Detection Elimination
 - Determining where illegal tie-ins to the municipal stormwater system exist and removing them.
- Best management practices to prevent stormwater pollution





What Is Stormwater?

When it rains, the water that doesn't
evaporate or go into the ground, but
collects and runs off from pavement,
roof tops and other impervious
surfaces.









Increases Filtration Costs of Drinking Water






What Is IDDE

- IDDE Illicit Discharge Detection and Elimination
- Determining if there are illegal connections to the storm drain system and then removing them.





The Municipal Storm Water System







What Are Illicit Discharges?

- Illegal or illicit discharges include but are not limited to:
 - Pipes, drains or ditches that lead to the storm drain system from: sewers, process wastewater, wash water, any connections for indoor drains and sinks (even if previously approved).
 - Any connections to the stormdrain system from a commercial or industrial land use which has not been documented and approved (How do I know if its been documented?).

What Discharges Are Legal?

- Legal discharges include:
 - Uncontaminated waters that run off your site when it rains
 - Wash water from washing vehicles if no soap is used
 - External building washdown when no detergents are used
 - Dechlorinated pool discharges
 - Air conditioning condensate
 - Irrigation drainage
 - Foundation or footing drains, roof runoff and sump pumps where flows are not contaminated.





Trivia – Legal Or Illegal Discharge?

- Indoor sink leading to stormdrain? Illegal
- Sump pump used in dewatering basement? Legal
- Parking lot runoff that leads Legal As long as its documented and no spills are present
- Washing machine plumbed to stormwater system? Illegal





Is It Legal or Illegal??

When in doubt:

If the water has any chemicals, soap, grease, oil, etc. in it (IT'S NOT JUST WATER) then it shouldn't go down the stormdrain.







What Do I Do If I Have An Illegal Discharge?

- RIDEM?
- Get a plumber to disconnect?
- Any other requirements?





Stormwater and BMPS

- BMPs = Best Management Practices
- Things you do everyday that help reduce pollution from your business.
- Certain ones are now required.

Storage of Hazardous Materials

- Keep them under cover: inside a building, under a covered area, under a tarp
- Secondary containment
- Storage away from areas where can leak and flow into stormdrains or waterways (near sump pumps for groundwater removal, near stream, wetlands, rivers, etc)

Do You Have Dry, Cleaning Materials Available?

- Clean spills using dry, cleaning material (saw dust, kitty litter, broom or mop).
- Don't use water to rinse off a spill.

Cleaning Floor Mats, Filters And Garbage Cans

- Pour wash water from floor cleaning into a mop sink, not outside.
 - Clean floor mats, filters and garbage can in the mop sink .
 - Never pour grease and oil down the drain.
 - They can be recycled.





Washing Cars?

- If you use soap, then divert wash waters away from stormdrains.
- Wash the cars somewhere where water can soak into the ground.







Dumpsters

- Keep them covered so they don't fill with water and keep trash in.
- Plug any holes in the dumpster or ask for a new one.

Trash

- Trash leaving the site is your responsibility.
- Have readily available trash cans and empty them regularly.











Water Courses

• Keep any streams, river, ponds, bays, wetlands free of trash, lawn clippings/leaves.







Industrial Permit

- Specific industrial activities must obtain a permit under the Industrial Activity Multi-Sector General Permit.
- Check to see if your SIC code requires you to obtain a permit.
- General categories covered: manufacturing (metals, chemicals, textiles, etc.), auto salvage, marinas, transportation and food processing.

Check RIDEM website (<u>http://www.dem.ri.gov</u>) under the RIPDES program (under water resources) for permit information.





Additional Activities

- Pave loading and unloading areas
- Grade away from water courses and stormdrains
- Keep rainwater out so it will not pool at the bottom.







Additional Activities

 Divert roof leaders, foundation drains, air conditioning condensate onto grassy areas.
